Soles, Jr. In 2001 he initiated for MCHS a five-year plan with the county – the New Point Comfort Lighthouse Preservation Task Force and was instrumental in the publication and funding of *New Point Comfort Lighthouse Its History and Preservation* that was launched in 2013. Stay tuned for information on the commemoration, celebration and promotion of this treasure from Mathews County's past.

2021 promises to be a good year for Mathews County and the society. Thank you, the membership, for your support, validation and confidence in the work we are trying to do.
